Acceptable Use Agreement 2023

We ask that parents please read this information with their child/ren. **Students will not be permitted to use technology at school until this form has been signed via Compass.**

School profile statement

At Keilor Heights Primary School, we support the right of all members of the school community to access safe and inclusive learning environments, including digital and online spaces. Parents should also be aware that many of the most popular social media forums have a minimum age requirement of 13 years for all registered users and therefore Primary School aged children are not legally allowed to have their own profile. Digital technology, if not used appropriately, can present risks to your child's safety or well-being. We ask that students not have any social media applications installed on their BYO iPad. Keilor Heights Primary School defines social media as any means of digital communication that enables users to create and share content or to participate in social networking – in and outside school. This includes, but is not exclusive to Instagram, Facebook, Instagram, Youtube, TikTok, Snapchat etc. This form outlines the School's roles and responsibilities in supporting safe digital learning, as well as the expected behaviours we have of our students when using digital or online spaces.

At our School we:

- Have an **eSmart Policy** and **Student Engagement Policy** that outline our School's values and expected student behaviour, including actions and consequences for inappropriate online behaviour;
- Educate our students to be safe and responsible users of digital technologies;
- Educate our students about digital issues such as online privacy, intellectual property and copyright;
- Supervise and support students using digital technologies for school-directed learning;
- Provide a filtered internet service to block inappropriate content. We acknowledge however, that full protection from inappropriate content cannot be guaranteed;
- Use online sites and digital tools that support students' learning;
- Address issues or incidents that have the potential to impact on the wellbeing of our students;
- Refer suspected illegal online acts to the relevant Law Enforcement authority for investigation;
- Engaged with the Cyber Safety Project and teach the Cyber Safety Curriculum
- Support parents and caregivers to understand safe and responsible use of digital technologies and the strategies that can be implemented at home. The following resources provide current information from both the Department of Education & Training and The Children's eSafety Commission:

Keilor Heights Primary School Technology Agreement

When I use digital technologies, I **protect personal information** by being aware that my full name, photo, birthday, address and phone number is personal information and is not to be shared online. This means I:

- protect my friends' information in the same way
- protect my passwords and don't share them with anyone except my parent
- only ever join spaces with my parents or teacher's guidance and permission
- never answer questions online that ask for my personal information
- know not to post three or more pieces of identifiable information about myself.

When I use digital technologies, I **respect myself and others** by thinking about what I share online. This means I:

- ensuring my iPad is fully charged at the beginning of each school day
- stop to think about what I post or share online
- will not share or post the link (or password) to video conferencing meetings, with others offline in public communications or online on public websites or social media forums
- use spaces or sites that are appropriate, and if I am not sure I ask a trusted adult for help
- protect my friends' full names, birthdays, school names, addresses and phone numbers because this is their personal information
- speak to a trusted adult if I see something that makes me feel upset or if I need help
- speak to a trusted adult if someone is unkind to me or if I know someone else is upset or scared
- don't deliberately search for something rude or violent
- turn off or close the screen if I see something I don't like and tell a trusted adult
- I am careful with the equipment I use.

At school we/I have:

- discussed ways to be a safe, responsible and ethical user of digital technologies.
- presented my ideas around the ways that I can be a smart, safe, responsible and ethical user of digital technologies.

I will use this knowledge at school and everywhere I use digital technologies.

This Acceptable Use Agreement applies when digital devices and technologies are being used at school, for school-directed learning, during school excursions, at camps and extra-curricular activities, and at home.
